Vote By Mail report was presented with the following: to date 339,521 ballots have been mailed; 64,799 ballots have been returned; 299 ballots returned with voter errors.

3 voter certificate signature protests were presented to the Board for review. The Board accepted 3 and rejected 0.

The Board was presented with 6 ballots to determine voter intent. All ballots were then sent for duplication in accordance with *Standards for Determining Voter's Choice on a Ballot, IS-2.027*.
